

Canadian Scrapbooker Inc – Monthly Trivia Contest
June 11 – July 11th, 2010
Official Contest Rules & Regulations

This contest is sponsored by Canadian Scrapbooker Inc. (“contest sponsor”). The contest runs from at or about 12:00:01 a.m. M.S.T. June 11 to 11:59:59 p.m. M.S.T, uly 11th, 2010 (the “Contest Closing Date”).

Prize

Eligibility

The contest is open to all **legal residents of Canada** that have reached the age of majority in the province or territory in which they reside at the time of entry. Employees (and persons with whom they are domiciled) of the Contest Sponsor, its agents and representatives, its parents, affiliates, subsidiaries and dealers, advertising and promotional agencies, as well as suppliers of materials or services related to this Contest, are not eligible to enter the Contest.

To Enter

No Purchase Necessary. There is 1 way to enter:

1. Online entry: To enter on-line, visit www.canadianscrapbooker.ca and follow the links to **Monthly Trivia Contest**. Complete the questionnaire in full.

Only submissions with the correct response will be qualified for the draw.

Limit of one entry per person. In the event it is discovered that you attempted to enter more than once, then your entry will be voided. All personal information obtained for this Contest will be used for the purposes of conducting the Contest.

Entries that are incomplete, lost, stolen, late, delayed, misdirected, illegible, damaged, altered, irregular, destroyed, have been submitted through illicit means, or do not conform to or satisfy any conditions of the Official Contest Rules and Regulations shall be disqualified.

Draw

The selected entrant will be contacted by email, courier or telephone within five (5) business days of the draw date. If the selected entrant cannot be contacted within five (5) business days, he/she will be disqualified and a new random draw from the remaining eligible entries will be conducted to select another entry and the process noted above will be repeated until a selected entrant is contacted or there are no more eligible entries, whichever comes first.

Before being declared a winner, the selected entrant must first correctly answer without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question within ten (10) business days of the draw date. The selected entrant will also be required to sign a Declaration and Release Form (the "Release Form") confirming compliance with these Official Contest Rules & Regulations, acceptance of the Grand Prize as awarded without substitution, and releasing the Contest Sponsor, its affiliated and related companies, advertising and promotional agencies, the independent contest judging organization, and their respective shareholders, directors, officers, employees, agents, dealers, representatives, successors and assigns from any liability in connection with the Grand Prize or this contest.

General

In the event it is determined that an entrant has entered in a fashion not sanctioned by these Official Contest Rules & Regulations, the entrant will be disqualified and all of the entries submitted by the entrant will be disqualified. Entries are subject to verification by the independent contest judging organization.

The Contest Sponsor, (or the independent contest judging organization) reserves the right to void any entry and/or cancel or modify the Contest in whole or in part (without notice to entrants individually) if, in its sole discretion, it determines that for any reason the Contest is not capable of running as originally planned, fraud, technical failures, human, printing or distribution errors, or any causes or occurrences have compromised the administration, safety, fairness or integrity of the Contest.

In the event of a dispute, entries made by Internet will be declared made by the Authorized Account Holder of the e-mail address submitted at time of entry. "Authorized Account Holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g. business educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

Any person entering the Contest or trying to do so by any means which go against the intention of the Official Contest Rules & Regulations and which would be unfair to the other participant will be automatically disqualified and the Contest Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.

All entries become the permanent property of the Contest Sponsor. No correspondence will be entered into except with the selected entrant. This Contest is subject to all applicable federal, provincial and municipal laws and is void where prohibited.
